IN CONSIDERATION of being permitted to participate in any way in the sport and activities of paintball and/or airsoft on the premises of Insane Paintball, LLC, I acknowledge, appreciate and agree that:

1. The risk of injury from the activity and weaponry involved in paintball and/or airsoft is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist.
2. I knowingly and freely assume all such risks, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE of those persons released from liability above, and assume full responsibility for my participation, and:
3. I understand that the activities of paintball and/or airsoft are physically and mentally intense. I understand the rules of play and will comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official or employee as soon as practical and:
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS FROM LIABILITY, Insane Paintball, LLC, (the owners and lessors of premises used to conduct the paintball activities) their officers, officials, agents and / or employees, WHETHER CAUSED BY THE NEGLIGENCE OR THE RELEASEES OR OTHERWISE.
5. I understand and agree that this Release of Liability Agreement covers each and every paintball and/or airsoft activity and event in which I participate hereafter.
6. I have read the rules of conduct for Insane Paintball and/or Airsoft and understand that failure to follow the rules could result in expulsion from the facility, without a refund. Insane Paintball, LLC reserves the right to amend the rules at any time.¹

Rules for Paintball & Airsoft Games

Initial

_____ I understand that Insane Paintball is field paint only and only field paintballs purchased from Insane Paintball are allowed to be shot unless otherwise noted and/or approved for a special event, practice, etc. Violators may be asked to leave without refund.

_____ I understand that I must have a wrist band on my wrist to enter a playing field.

_____ I understand that I must use a barrel blocking device (barrel plug, or barrel cover) at all times when not on a field.

_____ I understand that I must keep my mask on at all times when on the field.

_____ I understand that the maximum velocity for paintball guns is 275 feet per second. Maximum for airsoft guns is 400 feet per second.

_____ I understand that no fully automatic paintball guns are allowed.

_____ I understand that guns are not to be shot anywhere but on the field of play. Violators will be asked to leave without refund.

_____ I understand that I am responsible for any rental equipment that I receive, and I agree that I will return all items that are rented. Unreturned items will be charged to me at retail price for replacement.

_____ I understand that Insane Paintball & Airsoft does not tolerate players who do not call their hits. (cheating, wiping, playing on, etc. is not acceptable) Violators may be asked to leave without refund.

_____ I understand that I am not allowed to shoot a gun or play on a field if a staff member is not on the field.

_____ I understand that alcohol and drugs are not permitted on the Insane property. Players that are suspected to be under the influence of drugs or alcohol will be asked to leave without refund.

_____ I understand that foul language is not tolerated and violators may be asked to leave the property without refund.
